We are reputed importer and regularly import our requirement from various countries through the vessel owned/operated by your Principals CULINES for whom you act as agent.

The above mentioned consignment/s have landed on jnpt/ Mumbai port,we intend to dispatch the containers by road from jnpt/Bombay port trust premises to

In this connection all formalities with the customs/port authorities etc,will be our responsibility and all costs will be borne by us.

We also agree that consequent to the movement of containers to our premises,we will indemnify the carriers or their assignees against any or all loss damage,liability,cost or

Expenses suffered or incurred by the movement of containers under our jurisdiction arising our of or connected with injuries to or death to other person/s or loss of damage to property of other person/s arising out of the use,operation maintenance or possession of your principals containers by us or our authorities representatives.

We also agree that we will be liable for detention charges after the first 5 free working days of the jnpt/bpt nominated site.If the containers are not redelivered within the said

Free period.We shall be liable to pay detention charges as per Bombay steamer agents Association schedule/effective tariff governing Bill of lading.

We further undertake to redeliver the container's to you as above within 15 days from the date of receiving the containers' from the docks. We also undertake to ensure that utmost care is taken by us for the safe transit handling and delivery of containers. We shall be held responsible for any damage to the container's and will settle such amounts as may be assessed by the surveyors deputed by you for any damage to the containers while in our custody.

We undertake to pay a sum of Rs.271000/- (Rupees Two Lakhs seventy One Thousand only) 1 x 20', 1 x 40' Rs.4,54000 (Rupees Four lakhs fifty four thousand only) 1x 20' Refer Rs.26,52,000/- (Rupees Twentysix Lakhs Fifty Two Thousand only) Container which includes the value of the container and customs duty levied on it to You as deemed, in case we fail to return the container/s in the requisite time period stipulated or due to total loss of the container/s.

The empty container/s will be returned to your location. We undertake to clear all outstanding charges prior to cancellation of this guarantee.

We shall produce the bill of entry duly endorsed by customs while removing/returning the said container within 7 days from the date of redelivery of empty container/s at your
